6. Opt-Out Options

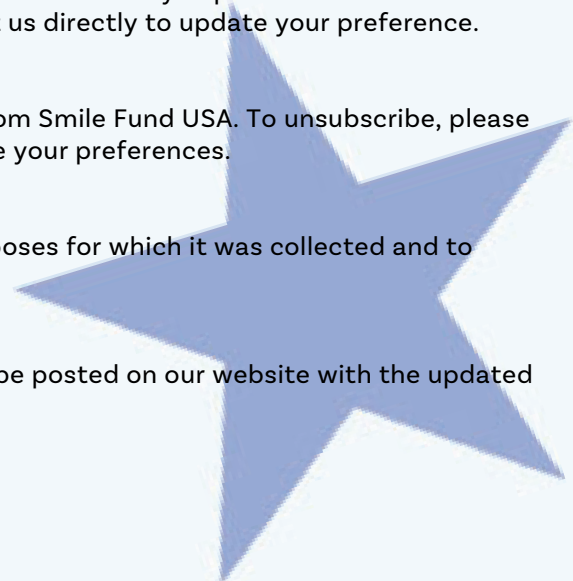
