1. Fair Market Transactions

2. In-Kind Contributions

5. Designation of Donations

All contributions, whether financial or in-kind, are designated to further Smile Fund USA's mission. This may include funding the issuance of grant vouchers, providing direct care to patients, or supporting operational needs. Designation statements should clarify the intent, such as:

"For the issuance of grant vouchers or the provision of dental care to underserved communities."

6.1 No Obligation: Donations to Smile Fund USA, including in-kind contributions, are entirely voluntary. There is no obligation for continued contributions or participation beyond the initial donation.
